Creative Ways to Give to the Building Fund

Here are some ideas that might make giving to the Building Campaign a bit easier on the pocketbook in certain circumstances. Both strategies are designed to enhance exclusions from tax despite the limits on the deductibility of charitable contributions otherwise applicable under existing law. You should check with your tax or financial advisor about the suitability of such approaches for your specific situation. But here are some things to investigate.

Long-Term Assets

Gifts of stocks or bonds that have been held long enough to qualify as long-term capital gains (generally for more than a year) can be deducted at the fair-market value rather than the price at which you bought them. If you bought stock for \$20,000 that, ten years later, is now worth \$40,000, you can donate the shares to an approved 501(c)(3) organization and deduct the full \$40,000 without having to sell the shares. St. Paul's is a 501 (c) (3) organization. The church can work with you to accept a transfer of these types of assets and can use their value to pay for the construction.

Qualified Charitable Distribution

The Qualified Charitable Distribution (QCD) rules allow taxpayers to make IRA distributions payable directly to a qualified charity without treating the distribution as taxable income. This law currently permits up to \$108,000 per eligible IRA owner to be contributed directly from their IRA to charity. In addition, the distribution can be used to fulfill the IRA owner's Required Minimum Distribution (RMD) for the year. The IRA account holder must be aged 701/2 years old or older as of the date of the distribution.

Study Window for May 2025

Looking out my study window, I am thinking about sheep.

In the 15th chapter of Luke, Jesus is telling stories to his disciples. I have always appreciated individuals who can tell a good story. It is something that I am not particularly good at. I am told by my wife and others that I get to the point too quickly and do not take the time to add in the small details that make stories interesting. I have actually taken a class on storytelling to try to improve. And as a history buff, I have always appreciated the engaging way that Abraham Lincoln used storytelling to entertain and more importantly to make his point.

Jesus is also a good storyteller. If he were not, I doubt that people would have worked so hard to collect his stories and record them for the future. The particular story I have in mind is about sheep. Jesus talks about a shepherd who leaves his flock to search for one lamb who has wandered off. It is an odd story because it seems to praise a shepherd who is obviously derelict in his duties. The shepherd's job is to protect the flock, not just one wayward sheep. By leaving the flock behind, he is leaving it unprotected and at risk of predation by wild animals.

The simple economics of what is at stake would make it clear that his values are all wrong. The shepherd should stay with the flock, where the great financial worth is located, and not chase off after one stray. Although, this is the same calculation that the Pharisees and the Chief Priests made in John 11 when Caiaphas says it is better to let one man die (Jesus) than to have the nation destroyed by the Romans. Caiaphas predicts this will happen if this Jesus, who seems to him to be straying from some of the teachings of Judaism, is allowed to continue.

Nonetheless in Luke 15, Jesus, being a good storyteller, is using a surprising twist to make an important point. One that we might more easily remember because of the unexpected approbation of the shepherd. The point, in part, is to illustrate how important individuals are to God. They are just as important as the entire "flock" of followers. That is a stunning thought! Maybe we have heard that so many times that we take it for granted. But see if you can imagine hearing this for the first time as you are sitting around listening to Jesus spin his yarns. If you can, how do you feel if YOU are the stray? If YOU are the flock?

This little story concludes with the shepherd finding the lost sheep. (We do not hear how the flock fared, but then it is only a story.) And then Jesus hammers the point home. This shepherd, upon returning to the flock with the stray in tow, invites everyone to a big party because the one that was lost was found. What unexpected and undeserved extravagance!

When we hear stories about Jesus' special regard for an individual, a healing, an exorcism, or being raised from death for example, we may be tempted to think there was something special about the one who received the blessing. Actually, there was not. It turns out that each of the sheep is important to God. And when one goes astray or gets into trouble, our God always goes looking for them. God will find them and will welcome them home if they but turn back to God (or in fancy church talk: "repent").

This simple and affirming truth seems difficult for us to learn. We are still too prone to believe that blessings are given only to those who "deserve" them. As if we can "earn" God's favor. We cannot. That is why there is something called grace. Grace that is greater than all our sin, to quote the old hymn.

We will be in the season known as Eastertide until Pentecost on June 8. So, we have plenty of time to reflect on the power of God's love for us on this side of the Resurrection. And to listen for the voice of the Shepherd--who is calling us by name-- to come back to the flock.

My prayer for us is that we may be attuned to the Voice. The Voice that knows us by name. The voice of the God who seeks and invites.
